Hi Dave,

I don't have a contract for McAfee, so assume whatever shrink-wrap or click-wrap license they send out with the software would apply. We've been going that route for 10+ years and it hasn't been a problem. I have attached the quote we processed the renewal under last year. Here are the assumptions I would make about McAfee software...

- We will not receive updates for whatever software we don't renew on 7/1/13.
- There should be no requirement to de-install software after 7/1/13, but we should cease distribution of all software we have not renewed at that time.
- Graduated students should not currently have access to updates, but neither should they need to de-install any software they have.
- Post 7/1/13, if we do not renew, any software that remains on computers will become
 obsolete pretty quickly I'd imagine. Users should be notified of this and informed of the new
 recommended solution.
